#### **ABOUT US**

This website <a href="www.consist.co.il">www.consist.co.il</a> including its related sub-domains (the "Website"), is operated by Consist (Israel) Software and Computer Solutions Ltd., Consist Systems Ltd. and Consist Technologies Ltd., affiliated companies incorporated in the State of Israel and with their registered office 2 Granit, Petah Tikva, Israel.

In this Cookie Policy when we refer to "Consist", "our", "we" or "us", we mean any of those Consist group companies and they are collectively referred to as the "Consist Group".

Our Website uses cookies. A cookie is a small text file that can be stored on your computer when you visit websites. If those cookies are not strictly necessary for the provision of our Website and services, we will ask you to consent to our use of cookies when you first visit our Website.

## WHAT IS A COOKIE?

Information is saved in this text file, such as your choice of language on a Website. When you visit the Website later again, this cookie returns to the concerned Website. In this way, the Website recognizes your browser and can for example retain your choice of language.

Cookies usually also have an expiration date. For example, some cookies are automatically deleted when you close your browser (so-called session cookies), while others can be stored longer on your computer, sometimes until you delete them manually (so-called permanent or persistent cookies).

#### **COOKIES THAT WE USE**

We use different types of cookies on this Website:

- (a) <u>Essential Cookies</u>. We use essential cookies to authenticate users, prevent fraudulent use of the Website, and to allow the Website and its features to function properly; and
- (b) Analytics Cookies. Our analytics providers use cookies as part of their tools. Analytics cookies allow us and our analytics providers to recognize and count the number of users to the Website, see how users interact with the Website and different functions, and when users are using the Website. We use this information to improve the Website.

When a user start browsing a unique session ID is created, which keeps track of all the information regarding that session. This information is stored in the web server and it is identified via a GUID. The GUID is essential for any ASP.NET site to function properly
cfduid	29 days 23 hours 59 minutes	The cookie is used by cdn services like CloudFare to identify individual clients behind a shared IP address and apply security settings on a per-client basis. It does not correspond to any user ID in the web application and does not store any personally identifiable information.
_ requestverificationtoken	At the end of the session	This cookie is an anti-forgery token (prevent CSRF attack). It guarantees that the poster is the one who gets the form. It prevents from anybody to forge a link and have it activated by a powered user. This cookie is created by the framework.
